Investment Objective

The portfolio's objective is to provide investors with exposure to the price movements of cryptocurrency and digital assets over the long term. Exposure to this global megatrend captures underlying investment themes related to the evolution of global financial infrastructure, social change, climate change, the digitisation of assets and democratisation of data. The portfolio does not currently invest directly in any cryptocurrency assets.

The portfolio will be invested into assets that have price and fundamental exposure to the crypto and digital asset market, including listed shares, ETFs, investment trusts and other instruments that allow us to achieve such exposure. As a rapidly developing market, the portfolio will evolve to take advantage of new products and companies that best allow us to gain exposure and add value to investors. At inception, the portfolio will primarily be exposed to Bitcoin related activities, which, as the dominant cryptocurrency, is the most openly available exposure. However, we will look to add to diversification across a wider range of crypto assets over time

The portfolio is designed for investors looking to obtain exposure to this long-term megatrend and are comfortable with potentially very high levels of volatility in the short-term. Investors should be able to tolerate large and frequent fluctuations in the value of their investment and who understand that this is a long-term investment (5-years +). The portfolio will be diversified to limit the potential for real long term capital loss and there will be a focus on portfolio liquidity should an investor need to exit their position.
